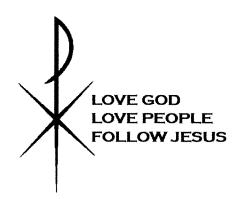

Pastor's Report 2022 Annual Report Christ, Preston, MN January 2023

Siblings in Christ,

Back in 2010 I was in transition from my call at Central Lutheran Church in Winona to a new call at Grace Lutheran Church, Mankato. Of course, I posted an announcement regarding this move on Facebook. Dr. Gary Simpson, one of my doctoral advisors responded, "Blessings during this Janus time." I had to look it up.

As Wikipedia states, "In ancient Roman religion and myth, Janus is the god of beginnings, gates, transitions, time, duality, doorways, passages, frames, and endings. He is usually depicted as having two faces."

It's no accident that "the month of January is named for Janus (*Ianuarius*)." It is normal for us to look back on the past year as well as to look ahead to the coming one.

Having only been at Christ Lutheran for three months, it would be presumptuous of me to comment on the entire year, though it is evident that a major event of note would be Pr. President's Report 2022

Where do we begin – my second year as Council President was far from normal. The church continued to feel the impact of COVID 19. Many people have started to come back to church and we are moving towards a new normal.

We were blessed with Pastor Dan's leadership to begin 2022. He continued to carry a large virtual presence for Christ Lutheran that continued with on-line worship. Of course, we also found that God was calling him in a different direction when he accepted a call to a Church in Ottumwa, OH, to be closer to family. And while, we were sad to see Pastor Dan move on, we were able to get our current interim Pastor Scott Olson.

I would like to give a big thank you to a few people. Pastor Dan, and Pastor Olson have both made my time as Council President enjoying and gratifying. Amanda, continues to keep everything flowing smoothly; to Dan and Deb who continue to take great pride in keeping the church clean. To Pam Ristau, for keeping the books together and completing payroll. Thanks to the worship and music team for coming together to plan our services. Big thanks to Tami Christianson for her beautiful organ music, Sarah Kling-Punt for her piano playing, and all the numerous worship leaders and musicians who bless the church with their time and talent.

The Council will lose 2 members this year. Bradley Leathers, served as the Treasurer in Year 1, Property Committee Year 1-3, and Church Council President for Years 2-3. Carol Solberg took the remainder of Dave Harrison's term this summer. Dave held the Youth Committee Chair position during his tenure serving on Council and we appreciate his hard work. Susan Pikula was also able to serve the remainder of Steve Corson's term through 2023. We thank you all for your contributions.

Team Highlights have been included in the Annual Report and as you see, all teams, and the Church continue to be affected by the changes to our landscape made by the pandemic. We are very grateful to our Evangelism & Stewardship team, Property Team, Youth, and Education Team, and the enormous contributions they make.

This year was even more challenging in meeting our budget, and unfortunately, we are not where we hoped to be at the end of the year. Most of that budgetary position can probably be contributed to replacing the front walkway, as that increased our costs year over year but we were able to see other savings elsewhere. We had a very strong Craft and Bake Sale when we were able to raise 9.5K. Giving continues to be extremely strong in the winter months, and lightens in the summer months. In completing the 2023 Budget, we trimmed expenses where we could, and included much needed raises for others. We also continue to encourage Simply Giving, an electronic form of giving. As always, we are open to any suggestions for trimming expenses where available.

We continue to have many congregational members that extend their time, talent, and tithe in many ways and are always willing to step up. We also continue to experience the need for additional volunteers in several areas so if you are willing and able, please get involved.

The largest most noticeable project that took place this year was replacing the front walkway. We were able to raise \$44,000 for that purpose, the project ended with \$28,000 in receipts thanks to the wonderful contributions of Scheevel & Sons who demolished the front walkway, and Solberg Welding who designed, built, and installed the railing. We thank you for your work and contribution.

I know that many our older parishioners had fond memories of the German and Norwegian Lutheran churches that combined all those years ago, and the walk that was made on that entryway in 1961. I hope that the entry will continue to be a beacon and welcome Parishioners, community members, and all who step foot on our Church Grounds for the next 60 years. We will be able to look at the walkway and all that we can accomplish moving forward together for the next 60 years.

This report highlights the awesome contributions made by the staff and congregation which makes Christ Lutheran a wonderful church and family to belong to.

Christ Lutheran Church Annual Meeting Minutes – Sunday, November 14, 2021

Council President Bradley Leathers called the meeting to order.

Steve Corson made the motion to approve the 2020 annual meeting minutes. Sue Hager seconded. The motion carried. No further discussion.

Pastor Dan reviewed his report. He is grateful to be able to gather together for in-person worship and is hopeful there will be a Christ Kids Christmas Program this year as we missed out last year due to the Covid-19 pandemic. Pastor Dan thanked all who donated their time and talent through partnership in ministry.

Bradley Leathers presented the Presidents report. He thanked Pastor Dan, Amanda, Danny and Deb, Tami, and Pam Ristau for their years of service to Christ Lutheran Church. He also thanked Jessica, Sara, and the music team for sharing their time and talent and Sue, Becky, Susan, and Carol for their service on council. Bradley talked about how the council tried to trim the budget as this is the second year without the church dinner and the decrease in revenue from that event.

Each Council Team Leader presented their report. Team leaders: David Harrison - Youth Team. Bradley Leathers - Property Team, Steve Corson - Music and Worship Team, and Sue Hager - Stewardship and Evangelism Team. Pastor Dan spoke on behalf of the Education Team as leader Rebecca Schwingle was absent. Teams did not meet in-person due to the covid -19 pandemic, with the exception of Property Team.

Auxiliary Reports from Altar Guild, WELCA, Christ Crafters, and Audit Committee were reviewed.

Mike Erdman presented the Financial Report. Mike spoke of the Federal PPP (Payroll Protection Program) Grant Forgiveness Loans in the amount of \$44, 962.15 included in the financial report.

Motion was made by Steve Corson and seconded by David Harrison to accept the Budget/Financial Report. The motion carried. There was no more discussion.

Nominating Committee Report: Kristen Bunge and Dawn Hellickson brought to the Annual Meeting the following names to fill positions for the 2022 Council: Sara Niemeyer, Michael Johnson, and Darrel Olson (3-year terms). A motion was made by Mike Erdman and seconded by Jim Keune to accept the nominees presented by the Nominating Committee. Motion carried.

There was further discussion regarding Steve Corson being interim council member. Steve will serve until a replacement is found (2-year term remains).

Sara Niemeyer questioned the possibility of a Student Representative on Council. Pastor Dan will check the church constitution before further discussion.

A motion was made by Brad Leathers and seconded by Dave Harrison for Alison Leathers and Steve Corson for Nominating Committee. No further discussion. Motion Carried.

Synod Assembly Delegates: Steve Corson and Carol Solberg will serve as 2022 Synod Assembly Delegates. Bradley Leathers will serve as alternate. Synod Assembly 2022 will be held Saturday, May 7 in Mankato, MN. This event is planned for in-person; however, discussion continues on the possibility of an online event pending Covid-19 restrictions.

A motion to adjourn was made by Rick Grooters and seconded by Michael Johnson.

The meeting closed with the Lord's Prayer.

2022 Education Team Update

2022 has been an exciting and fun year to be involved with our young youth of Christ Lutheran.

The year started out with continued Christ Kids programming during the Sunday morning worship services. This was a good way to begin some youth programming after Covid and allowed us to offer something with limited teacher/volunteers. The kids put on a great Easter program during Palm Sunday that was enjoyed by all.

During the summer a few of the kids took advantage of an opportunity to participate in Vacation Bible School with Greenfield Lutheran in Harmony with a food truck theme. This was a good experience and may be continued in the future.

This past fall the education team decided to return to a tradition Sunday school schedule with classes taking place after worship service on Sunday morning and kicked it off with a fun football themed Rally Sunday on September 11th. Attendance has been great with approximately 50 kids attending on a weekly basis. We have split the kids into 3 age groups for class but begin each week all together in the theatre room to sing songs. The kids have sung during the worship service one Sunday each month. We have used the book Sword Fighting by Karyn Henley to guide our weekly curriculum. Each week we have been working with the kids to practice looking up bible verses in the Bible. This has been very rewarding to see them improve and begin to find the weeks verse by themselves.

In December the kids put on a fun and delightful Christmas program during the Sunday morning worship service the week before Christmas. This is always a highlight of the year for the kids and the congregation.

2022 was a year of change, learning and growth. We have an amazing group of volunteers who have selflessly dedicated their time and energy for our church's great kids. Christy Bakken has led the 4th - 6th graders, Michael and Margaret Johnson and Cassie Keene have worked together to lead the 1st - 3rd graders, and Jenna Pederson and Cari Ledin have led the preschoolers and kindergarteners as well as leading the music time. Sara Niemeyer has also been a big help with planning and executing. All volunteers have worked hard to engage the kids and prepare activities on a weekly basis to bring the kids closer to an understanding of God's word.

The education team enjoys seeing our church's kids every week and the time spent together. They are our future, and our future is bright!

Although the Evangelism Team has not met "in-person" this past year, we have continued to care for our church family and neighbors. As always, God is Good!

<u>Communion</u>: Dawn H., Mary G., and Carol S continue to offer communion at Traditions, Park Lane, Gunderson Harmony Care Center, Harmony Place, and Chosen Valley Care Center once a month, providing the facility is open to visitors. We distribute pre-filled communion cups to home bound members as well.

Drive By, Drop Off Food Drive to Benefit the Fillmore County Food Shelf, October 29, 2022: The food drive provided 321.00 pounds of food items along with \$150.00 for the Preston Food Shelf (the CLC Youth's Trick or Treat for the Food Shelf on Halloween has not been received yet) only made possible by the generous support of the community. We continue this generous giving through November and December with the grocery cart and basket in the Narthex. Food items are always needed at the Food Shelf, but especially at the holidays. Prior to the food drive, we had donated 905.00 pounds of food and produce and \$4190.00 (including a \$500 grant awarded through the ELCA).

<u>The Giving Tree:</u> The Giving Tree in the Narthex offers an opportunity to donate hats, mittens, socks, and other items for children and adults in the area who are in need. The items are distributed to Fillmore Central Schools, Fillmore County Headstart, and the Fillmore County Food Shelf in Preston throughout the fall and winter seasons. However, all friends and neighbors are welcome to give and take from The Giving Tree.

<u>Fund the Warmth - Warm Coats for Kids</u>: The Warm Coats for Kids Account is available for any child in need of a warm coat and/or boots for the chilly winter months. Sarah Niemeyer graciously agreed to be the contact person at Fillmore Central Elementary School. Donations for this account are accepted throughout the year.

A Gathering of Friends: Members of the Martha Bible Study gathered for fellowship, coffee, And dessert at The Harmony Place in Harmony on October 18 and at Park Lane Estate in Preston on October 26. A date has not been scheduled yet for fellowship at Traditions.

A word on Stewardship: If you were to attend a "stewardship" service, you'd likely get the impression that stewardship is an event that happens once a year, involves a giving envelope and is designed for the purpose of asking congregants to help cover church expenses. But actually, the core of stewardship isn't money. It's spiritual fruits: love, joy, peace, kindness, goodness, faithfulness — in addition to generosity and gratitude. Stewardship is about taking care of something we value and enabling it to grow, whether it be taking care of our church finances or our church family.

Christ Lutheran WELCA (Lutefisk Dinner) Account

Following two years of the pandemic, it was decided CLC (Christ Lutheran Church) would not host an annual Norwegian Dinner in 2021. Christ's Crafters meet twice a month at 1:00 PM on the first and third Thursday of the month in the Fellowship Hall. We average about 10 people each time. New members (as well as project ideas) are always welcome!

This group continues to have fun and fellowship while making a variety of items. Most of the items are donated to the annual Craft and Bake Sale, which is being held again this December in lieu of the Lutefisk Dinner. We also do several service projects throughout the year.

In April we made and donated Easter bags of goodies to the residents at both Park Lane and Traditions assisted living facilities in Preston.

Christ's Crafters makes the fleece blankets that are presented to the graduating seniors of our congregation. Several members also make the baby quilts given to families at the time of baptism.

In September we displayed and dedicated 57 mission quilts that had been assembled over the past several years. They have recently been delivered to the Lutheran World Relief warehouse in the Twin Cities for distribution. We will continue to work on them as time allows.

To Grow Upward in our relationship with God through worship, bible study and prayer.

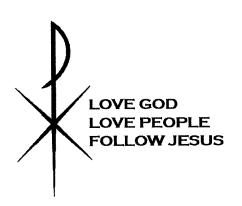
To Grow Inward in our relationship with each other through small groups, meals, fun events and Sunday morning fellowship.
